Reservations, Deposits & Payments The deposit is 50% of the trip price. Deposits may be made by transfer to our bank account. The balance of the trip cost is due 30 days before arrival. All prices must be paid in EURO. Prices do not include airfare. Deposits are not transferable from one trip to another. Prices quoted are based on foreign exchange values and tariffs currently in effect and are subject to change. We reserve the right to adjust prices accordingly until the time of departure.

Planning information When your reservation is confirmed, you will receive planning information to guide you through trip preparations. Details about arrival and departure, clothing and equipment and water conditions are included in the planning information.

Refund Policy If you must cancel your reservation, the following conditions apply: From 90 - 30 days prior to departure, the deposit is refunded less a 100 EURO (per group) administrative fee. 30 days or less prior to departure, the cancellation fee is 100% of the trip price. Cancellation fees cannot be waived for any reason, including health, business, personal emergencies, or weather. No refunds will be made for unused portions of a trip, including late arrival or early departure. We reserve the right to modify an itinerary due to circumstances beyond our control. In the unlikely event that we must cancel a tour, all payments received to date will be refunded, which constitutes a full settlement. We are not responsible for expenses incurred in preparation of any canceled trip, including airline tickets and visas fees.
